This is with reference to the disclosure(s) made by Samvardhana MotherSON International Limited (“the Company”) vide letter dated September 15, 2024, read with letter dated September 20, 2024, regarding subscription of up to 36,39,010 Class A Ordinary shares of REE Automotive Ltd. by, Samvardhana MotherSON Automotive Systems Group B.V., (“SMRP B.V.”) an indirect wholly owned subsidiary of the Company. Consequent to the completion of the aforesaid transaction intimated vide letter dated September 20, 2024, the Company via SMRP B.V. holds 18.6% of ordinary share capital in REE Automotive Ltd (11% on a fully diluted basis).

Now, REE Automotive Ltd. is raising further investment and has invited SMRP B.V. to further subscribe in the said fresh round of investment which is being done to support commercialisation of the orderbook.

Accordingly, the Company via its wholly owned subsidiary SMRP B.V. will invest between USD 5 to 7 Million to remain close to its current shareholding percentage in REE Automotive Ltd.

The aforesaid matter was considered by the Board of Directors of the Company at its meeting held on March 21, 2025. The Board Meeting of the Company commenced at 1630 Hours (IST) and concluded at 1800 Hours (IST).
